

# DUS Gateway Release Notes – Release 5.1.2

Fannie Mae will implement DUS Gateway<sup>®</sup> Release 5.1.2 on August 22, 2018. The system will be offline beginning 9:00 p.m. ET on Wednesday, August 22, with a maintenance window lasting until 8:00 a.m. ET on Thursday, August 23.

#### Key release highlights impacting Lenders:

- 1. Capture Win reasons on the deal page under Won/Loss section for both Standalone and Portfolio Master deals
- 2. Update Edit Decision pop-up on the Deal List page to reflect the Win reasons

## Additional details on Release 5.1.2 new functionality:

1. Capture Win Reasons on the deal page under Won/Loss section for both Standalone and Portfolio Master deals

Similar to Lost reasons, the lender has to select the **Deal Competitor** and at least one other Win reason when the deal decision is Won.
