
Q3 2025 DUS GATEWAY UPDATE



Fannie Mae will update the data requirements in DUS Gateway[®] for all Mortgage Loans, effective on **July 25, 2025**.

The following updates will be made to the data requirements in DUS Gateway for all Mortgage Loans, which will also impact API calls.

Summary of Changes

- Updates to the allowable values of the "Structured" field on the Deal page.
- After May 1, 2025, you will be able to enter "First Name", "Middle Name", and "Last Name" of an individual person when you link a Broker/Correspondent Company to a Deal. After June 26, 2025, only "First Name" and "Last Name" will be required.
- An attestation at the time of Deal submission is required to confirm the "Executed Correspondent Agreement", when a Deal has a "Broker/Correspondent? = Yes".
- New required field "Is the Seller the Loan Originator?" on the "Deal Detail" page for all Deals.
- Updated "Green Building Certification" allowable values.

Details of Changes

- Updates to the allowable values of the "Structured" field on the "Deal" page.
 - o Relabel the existing allowable value:
 - "Credit Facility Substitute Advance" to "Credit Facility Substitution Advance";
 - Add a new allowable value:

- "Bulk Delivery Other"; and
- Remove allowable value:
 - "Credit Facility".
- After the May 1 release, you will be able to enter "First Name", "Middle Name", "Last Name" of an individual person when you link a Broker/Correspondent Company to a Deal. After the June 26 release, only "First Name" and "Last Name" of the Broker/Correspondent will be required.
- An attestation at the time of Deal submission is required to confirm the "Executed Correspondent Agreement", when a Deal has a "Broker/Correspondent? = Yes".
- New required field "Is the Seller the Loan Originator?" on the "Deal Detail" page for all Deals.
- Reactivating two existing allowable values related to "Green Building Certification" on the "Property" page.
 - o Green Globes Multifamily for Existing Buildings;
 - o Green Globes Multifamily for New Construction; and
 - Green Globes Multifamily Performance Plus for New Construction.
- When uploading a Delegated or Non-Delegated Loan Document Modification Memo to Gateway users must:
 - o use file type .docx

Note: Gateway will issue an error message if any file type other than .docx is used

- o select "Legal" as the Document Category
- o select "Loan Document Modification Memo" as the Document Type

Note: a message prompt will appear once "Legal" is selected reminding users to select "Legal" and "Loan Document Modification Memo" when uploading either type of Loan Document Modification Memo.
