Subject: Lender Letter 24-03 – Loan Document Update

HIGHLIGHTS

Fannie Mae is announcing updates to the Loan Documents which may be used immediately and must be used for all Mortgage Loans with a confirmed Commitment Date on or after June 18, 2024.

New Documents

- We created 6418 and 6251.TIF to be used in transactions with tax increment financing programs. The Collateral
 Assignment of the tax increment financing documents includes a form of Consent to Collateral Assignment of
 the tax increment financing documents to be executed as a separate document by the applicable
 governmental authority.
- We created 6222 to replace 6222.MOD and 6222.SUB which are being retired. 6222 includes new and modified
 provisions for when rehabilitation work is being done at the Mortgaged Property. We revised 6102.13 to remove
 the reference to 6222.MOD.

Revised Loan Document

 We revised 6253 to clarify that the form isn't to be used with sponsor-initiated affordability restrictions or sponsor-dedicated workforce housing and to include a representation and a covenant regarding compliance with the rent restriction agreement.

Effective Date

The Loan Documents may be used immediately and must be used for all Mortgage Loans with a confirmed Commitment Date on or after June 18, 2024.
