Subject: Lender Letter 24-04 – Loan Document Update

HIGHLIGHTS

Fannie Mae is announcing updates to the Loan Documents which may be used immediately and must be used for all Mortgage Loans with a confirmed Commitment Date on or after August 28, 2024.

New Documents

- We created 6253.M.TEB to be used with approval of the Fannie Mae Deal Team for M.TEB transactions. Bond related definitions have been added as well a non-recourse carveout, event of default and indemnification of the lender.
- We created 6620.Borrower.TSLP that can be used for manufactured housing transactions.
- We created 6643 and 6643.Affiliate to be used with 6000 series loan documents post-closing.

Revised Loan Documents

- We revised 6103.SARM (SOFR) to include a non-recourse carveout for failure to pay to Lender all amounts due under any required Interest Rate Cap assigned to Lender. We also added a provision that the property condition assessment language remains in effect after the Conversion and is appliable to the converted Mortgage Loan.
- We revised 6251 to include drafting notes to clarify use of the form. Terms have been added to simplify the form.
 A power-of-attorney provision has been added to provide Lender the ability to take any actions it deems reasonably necessary to cure any non-compliance with the requirements of the Tax Abatement Program.
- We added clarifying drafting notes to 6276 and 6324.

Effective Date

The Loan Documents may be used immediately and must be used for all Mortgage Loans with a confirmed Commitment Date on or after August 28, 2024.
