



# **MSFMS** Release Notes

# Release 7.0

May 31, 2025

Multifamily Operations announces the release of Multifamily Structured Facility Management System (MSFMS) Release 7.0 on May 31<sup>st</sup>, 2025, with the enhancements described below.

#### **HIGHLIGHTS**

The updates to MSFMS in Release 7.0 include:

- Add property fields and rules (Property Purchase Price Amount & Property Purchase Date) for the purpose of Fraud Prevention
- Effective May 31st, 2025, MSFMS Release 7.0 The release includes the changes listed below:
  - 1. Property Collateral Underwriting Valuation Screen (both Base and Seniors)

Adding new required fields:

- **Property Purchase Price (\$):** The dollar amount of the purchase contract price not including the soft cost (e.g., legal fees, financing fees, appraisal fees, etc.) paid by the participant (i.e., borrower) for the property.
- Property Purchase Date (mm/dd/yyyy): The date on which the property ownership is transferred to the borrower.

## **Effective Date**

MSFMS 7.0 changes are effective May 31st, 2025.
