

Multifamily Asset Management Portal (MAMP) Release Notes – Release 7.1

Fannie Mae will implement Multifamily Asset Management Portal (MAMP) Release 7.1 on Friday, August 16th, 2019, which includes the following enhancements.

Key Release Highlights:

- MAMP is Single Sign On (SSO) enabled, and Servicers can login to MAMP using the Fannie Mae User ID and password.
- Servicers can utilize and upload the revised MBA Standard Property Inspection Form Version 3.03.

Detail Description of Changes:

Single Sign On (SSO) in MAMP:

- We have heard your feedback and are excited to announce that MAMP will be Single Sign On (SSO) enabled after 5 PM ET on Friday, August 16th, 2019.
- Users no longer need to create and maintain a separate password for MAMP.
 You can use the same Fannie Mae password to login to MAMP as you do for all SSO enabled Fannie Mae applications.
 - Users who currently have access to other SSO enabled applications can use their SSO password to login to MAMP.
 - Users who currently do not have access to other SSO enabled applications <u>must reset their password</u> as described below to login to MAMP.
- Users will now be required to access MAMP from a **NEW** URL on fanniemae.com: https://multifamily.fanniemae.com/applications-technology/asset-management-portal
- MAMP's current URL (https://hcdinfoexchange.fanniemae.com) will be deactivated. If you have bookmarked the old URL, please delete it.

Password Reset:

- As a security measure, users will be prompted to reset their SSO password every 90 days. Fannie Mae will send out email reminders that the password is about to expire.
- Users can reset their SSO password in Technology Manager or by using the self-serve password reset tool at https://glass.fanniemae.com/fl8ui/#/signin/forgot-password.
- The self-serve password reset tool can also be accessed from the Single Sign On login page by clicking on "Need Help With Your User ID and Password?".





New User Access:

- For now, new users should continue using the access form available on fanniemae.com to request access in MAMP (https://www.fanniemae.com/content/forms/multifamily-asset-management-servicing-user-registration-form.doc).
- We are planning to retire this access submission process in 2020 in favor of utilizing Technology Manager for MAMP, where a designated Technology Manager administrator at your company can manage user access for all Fannie Mae applications. We will communicate again once we are ready to make this transition.

• Other Items of Note:

- o If a user is inactive/hasn't logged in for more than 90 days in <u>any</u> SSO enabled system, their User ID will be locked, and a password reset will be required.
- If a User ID is locked for more than 90 days, it will automatically be deactivated by the system. Reactivation of a User ID will require submission of a new user access form.

Changes to Property Inspections Module

Bulk Submission and Automatic Data Extraction Changes

- The Property Inspections module will allow users to upload the revised MBA Standard Property Inspection Form Version 3.03, using either the existing Bulk Upload tab or the single upload functionality.
- All guideline and origination workitems, including both Interior/Exterior and Exterior Walk-Around inspections, should be submitted on the MBA Standard Property Inspection Form.
- As communicated previously, Servicers can continue to utilize and upload the old Version 2.07 until **December 31**st, **2019**. This release does not



- contemplate any changes to Version 2.07.
- Servicers are required to utilize and upload the revised MBA Standard Property Inspection Form Version <u>3.01 or 3.03</u> starting January 1st, 2020 and beyond.

Considerations When Uploading the Revised MBA Standard Property Inspection Form Version 3.03

- MBA Standard Property Inspection Form Version 3.03 upload file undergoes the same validations that are applicable to Version 3.01.
