Subject: Lender Letter 23-01 – Loan Document Update

HIGHLIGHTS

Fannie Mae is announcing new Loan Documents for transactions in Puerto Rico, a new Loan Document for waiver of sovereign immunity, and a revised Interest Rate Cap Reserve and Security Agreement. The Loan Documents may be used immediately and must be used for all Mortgage Loans with a confirmed Commitment Date on or after February 6, 2023.

New Loan Documents

- We have created forms for use in Puerto Rico for fixed-rate loans with terms of less than twenty (20) years secured by property held in fee simple. Note that:
 - o 6401.PR must be used in place of 6401, 6402.PR must be used in place of Form 6402, and 6421.PR must be used in place of Form 6421;
 - o 6010.PR must be used in addition to the standard published 6010;
 - o Both 6025.PRI and 6025.PR2 are required; and
 - Detailed Guidance on the Puerto Rico documents may be obtained from your Deal Team.
- We have also created a waiver of sovereign immunity form for use if the title policy for the Mortgaged Property includes an ALTA
 48 endorsement or Borrower or Guarantor otherwise discloses that Borrower or Guarantor is a member of a "Tribe" (as identified
 in the Federal Register), or that any Person that directly or indirectly controls or owns more than 50% of the ownership interests
 in Borrower or Guarantor is a Tribe or a member of a Tribe.

Revised Document

A conforming change has been made to 6442 since the December 2022 publication.

Effective Date

The Loan Documents may be used immediately and must be used for all Mortgage Loans with a confirmed Commitment Date on or after February 6, 2023.
